THE MARIAN HOUSE TRANSITIONAL SUPORTIVE HOUSING PROGRAM (MARIAN HOUSE I AND II) PROVIDES COMFORTABLE, STRUCTURED COMMUNITY LIVING WITH SUPPORTIVE SERVICES SUCH AS MEALS, PERSONAL SUPPLIES, REHABILITATIVE COUNSELING, LIFE-SKILLS TRAINING, JOB READINESS, PRE-GED AND GED EDUCATION, REFERRALS FOR MEDICAL CARE, AND A SAVINGS PROGRAM TO PREPARE WOMEN FOR INDEPENDENT LIVING. DURING THE YEAR WE SERVED 66 SINGLE WOMEN IN THE FIRST PHASE OF OUR PROGRAM. THE TRANSITIONAL FAMILY PROGRAM SERVES PREVIOUSLY HOMELESS WOMEN AND THEIR CHILDREN WITH HOUSING, TUTORING, EDUCATION, EMPLOYMENT ASSISTANCE, AND OTHER ENRICHMENT SERVICES. DURING THE YEAR THIS PROGRAM SERVED 24 FAMILIES; 24 WOMEN AND 40 CHILDREN. MARIAN HOUSE III, THE PERMANENT SUPPORTIVE HOUSING PROGRAM, SERVES PREVIOUSLY HOMELESS WOMEN AND THEIR CHILDREN.
